Updates to employee application

The Insure Oklahoma online employee application was recently updated. Please note the following changes:

- **Absent Parent** -- Personal information on a child's parent who does not live in the applicant's household will no longer be required. The application will continue to ask whether both parents are in the household and the reason for any absence, but no names or locations will be collected.
- **Sibling Relationships** -- New questions have been added to determine sibling relationships in certain households. These questions will only appear **if** there is more than one child on the application **and** at least one child has no parents in the household.
